## Biographical Note:

Robert E. Tranquada (1930- ) served as Chancellor and Dean of the University of Massachusetts Medical School (UMMS) from 1979 until 1986. Prior to his arrival at UMMS he held positions at the University of Southern California (USC) School of Medicine and at the University of California, Los Angeles (UCLA) School of Medicine.

Born in Los Angeles, California, Tranquada graduated *summa cum laude* from Pomona College in 1951. That same year he married Margaret Janet Martin with whom he had three children, John, James, and Katherine. He earned his medical degree from Stanford University School of Medicine in 1955. From 1955 to 1957 he was an Intern and Resident in Medicine at UCLA Medical Center and from 1957 to 1958 he was Resident in Medicine at Los Angeles V.A. Hospital. Tranquada held a Fellowship in Diabetes and Metabolic Diseases under the United States Public Health Service (USPHS) at UCLA Medical Center from 1958 to 1959 and was a Fellow in Diabetes (USPHS) at USC School of Medicine from 1959 to 1960. He held academic appointments at USC School of Medicine from 1959 to 1976, including Chair of the Department of Community Medicine and Public Health from 1966 to 1969. From 1965 to 1966, following riots that devastated the Watts area of Los Angeles, Tranquada helped re-establish health services as Associate Project Director for the Watts Health Center (South Central Multipurpose Health Services Center).

In 1969 he was appointed Associate Dean of the University and was influential in developing and strengthening educational components of the Charles R. Drew Postgraduate Medical School, now Charles R. Drew University of Medicine and Science. From 1974 to 1976 Tranquada was Regional Director of the Central Health Services Region, Los Angeles County Department of Health Services and in 1976 was recruited to the University of California, Los Angeles as Associate Dean for Regional and Postgraduate Medical Education. At UCLA he directed residency programs and coordinated teaching activities for all of UCLA's affiliated teaching hospitals.

In 1979, Tranquada was appointed Chancellor/Dean of the University of Massachusetts Medical School. During his seven years in office, Tranquada started the tradition of Fall Convocation and began fundraising initiatives by appointing the first Director of Development. He also helped secure UMass Medical's position in the community by making connections with other hospitals and smaller clinics in the area. Under Tranquada's watch, both the MD/PhD. program and the Graduate School of Nursing began. As Chancellor/Dean he represented UMMS in the transfer of land to the Worcester Business Development Corporation for creation of the Massachusetts Biotechnology Research Park, a collaborative public and private enterprise.

Upon leaving UMass Medical School in 1986, Tranquada was appointed Dean of the School of Medicine at the University of Southern California where he was also Norman Topping/National Medical Enterprises Professor of Medicine and Public Policy from 1992 to 1997 and Director of the Health Administration Program at the School of Public Administration from 1994 to 1997. He retired from USC in 1997.

**Scope and Content:** This collection documents Tranquada's role as Chancellor and Dean of the University of Massachusetts Medical School from 1979 to 1986. Speeches and administrative documents make up the bulk of the collection. Also included are documents concerning the formation of the Massachusetts Medical Society's Corporation for Medical Information Development, press clippings, and transcripts of oral history interviews with Tranquada.
