The James P. Loughlin Papers chronicles Loughlin's career as a labor union leader in Massachusetts and the role he had in locating the University of Massachusetts Medical School and its affiliated hospital in Worcester.

## **Biographical Note:**

James Patrick Loughlin, in his role as Secretary-Treasurer of the Massachusetts State Labor Council, AFL-CIO, is credited by many people as being influential in locating the University of Massachusetts Medical School and its affiliated hospital in Worcester. Born in Worcester on October 28, 1910, Loughlin attended Worcester schools. He left St. Peter's High School in 1926 to work as a carpet weaver's apprentice at the Whittall Mills. After leaving Whittall Mills Loughlin worked as a tree surgeon for the WPA before beginning work at Brockets Brewery in 1934. Loughlin was introduced to organized labor when the brewery was unionized. He ran for and was elected vice-president of the local AFL-CIO Brewery Workers union in 1937. That same year he married Annette Amie Dubuc with whom he had five children: Patricia A., Mary Gail, Kathleen S., Sheila Jane, and Paul S. In 1942 he entered the Navy and served for two years. Following World War II Loughlin started a job as a bartender at the Coronado Hotel in Worcester. This secured his ties to the local bartender's union and he became Recording Secretary of Local 95 of the Hotel, Restaurant, and Bartenders Union. In 1948 he was elected Secretary-Treasurer and Business Agent for the union. He served as President and Executive Board Member of the Massachusetts State Council of the Hotel, Restaurant and Bartenders Union and was the first Vice President of the Worcester Central Labor Union.

In February 1962, seven years after the merger of the American Federation of Labor and the Congress of Industrial Organizations, Loughlin was elected Secretary-Treasurer of the Massachusetts Labor Council, AFL-CIO and held that position for seventeen years. Between 1964 and 1968, President Lyndon B. Johnson reportedly offered Loughlin a favor in exchange for labor's political support in Massachusetts. Loughlin responded that he wanted a medical school in Worcester. Loughlin and labor were strong advocates of public higher education and Loughlin believed that the children of workers could afford to get a medical education at UMass but not at any of the private medical schools. He also felt that the medical school would provide more jobs for Worcester. In his position as a state labor leader Loughlin lobbied for the release of federal funds for constructing the medical school and also helped dissuade Governor Michael Dukakis from halting the construction of the hospital affiliated with the medical school. In recognition of this role, Loughlin participated in the groundbreaking for the school and was given an engraved commemorative shovel.

Loughlin also served as Commissioner of the Worcester City Hospital and as a member of the Salvation Army, the Massachusetts Council on Crime and Correction, the State Manpower Commission, and the Governor's Apprentice Training Committee. He was Labor Chairman of the U.S. Savings Bond Drive for many years. In 1965 Loughlin was appointed to the new Advisory Council of the University of Massachusetts Labor Relations and Research Center (est. 1964) at the UMass Amherst campus.

Loughlin retired from his statewide labor position in 1979. He died on February 1, 1984.

**Scope and Content:** This collection documents Loughlin's career as a labor union leader in the Commonwealth of Massachusetts and his association with the University of Massachusetts Medical School. Photocopies of news clippings, invitations, programs, awards and commemorative items, documents, and correspondence related to Loughlin's union work are the bulk of the collection. Also included are printed versions of photographs acquired in digital form. These digital images are retained on an internal network drive.
