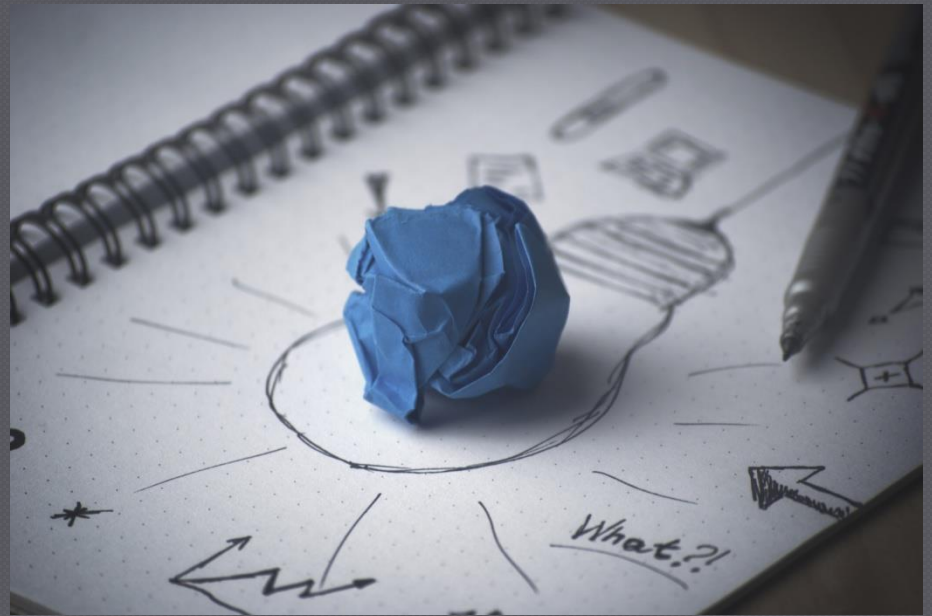
Step 1, Step Back
